

**HEARING UNDER SECTION 15 OF THE REGISTRATION OF ENGINEERS ACT 1967  
AGAINST Ir. CHONG CHI FUONG (P.E. NO.: 9113)**

**RESPONDENT:** Ir. Chong Chi Fuong (P.E. No. 9113)

**CHARGE 1:** *“That you, Ir. Chong Chi Fuong (NRIC No.: 690415-10-5033) (P.E. No.: 9113), being a director of Jentrikon Perunding Sdn. Bhd. (Company No.: 43507-D) an engineering consultancy practice, were at the same time a director of Sentral City (M) Sdn. Bhd. a construction company, for the period from 23<sup>rd</sup> October 2007 to date, without the approval of the Board. With that you have infringed Regulation 32(1) of the Registration of Engineers Regulations 1990. Therefore you have contravened Section 15(1)(g) of the Registration of Engineers Act 1967, with such contravention being punishable under Section 15(1A) of the Registration of Engineers Act 1967”.*

**CHARGE 2:** *“That you, Ir. Chong Chi Fuong (NRIC No.: 690415-10-5033) (P.E. No.: 9113), being a director of Jentrikon Perunding Sdn. Bhd. (Company No.: 43507-D) an engineering consultancy practice, were at the same time a director of CASA Construction Sdn. Bhd. a construction company, for the period from 18<sup>th</sup> July 2007 until 10<sup>th</sup> June 2011, without the approval of the Board. With that you have infringed Regulation 32(1) of the Registration of Engineers Regulations 1990. Therefore you have contravened Section 15(1)(g) of the Registration of Engineers Act 1967, with such contravention being punishable under Section 15(1A) of the Registration of Engineers Act 1967”.*

**CHARGE 3:** *“That you, Ir. Chong Chi Fuong (NRIC No.: 690415-10-5033) (P.E. No.: 9113), being a director of Jentrikon Perunding Sdn. Bhd. (Company No.: 43507-D) an engineering consultancy practice, were at the same time a director of Sentral City (M) Sdn. Bhd. a construction company and CASA Construction Sdn. Bhd. a construction company which are respectively the developer and contractor for project ‘Construction and completion of the Cadangan Membina Dua Blok Kondominium 21 Tingkat (286 unit), sebuah Rumah Kelab dan Pejabat Pengurusan 2 Tingkat dan sebuah Rumah di atas Lot PT 65978, Jalan Bunga Tanjung, Batu 14 Puchong, Mukim Petaling, Daerah Petaling, Selangor Darul Ehsan’. With that you have contravened Regulation 23 of the Registration of Engineers Regulations 1990. Therefore you*

*have contravened Section 15(1)(g) of the Registration of Engineers Act 1967, where such contravention is punishable under Section 15(1A) of the Registration of Engineers Act 1967”.*

**HEARING:** Held at 11:40 am on 16<sup>th</sup> April 2013 at Bilik Mesyuarat Utama, BEM, Tingkat 17, Ibu Pejabat JKR, Jalan Sultan Salahuddin, Kuala Lumpur.

**DECISION:** The Investigating Committee with the consent of the Disciplinary Committee withdrew Charge 1. Ir. Chong Chi Fuong (NRIC No.: 690415-10-5033) pleaded guilty to Charge 2 and Charge 3.
