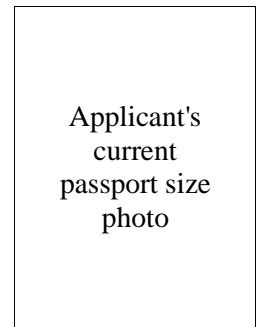

**PENALTY**
